The invited lecturer will trace back the history of TQM focusing on the founders of the concept of quality and its development from quality control to quality assurance, and then total quality management. During this lecture, quality awards provided in different countries of the world will be discussed including their impact on public organizations and different industries in the private sector. The focus is about the challenges that faced the success of TQM in different industries such as:

- Conducting proper training
- Practicing effective communication
- Integrating cross-functional integrations
- Setting appropriate key performance indicator or relevant metrics
- Appreciating employees and creating pride
- Establishing clear standards
- Celebrating success and promoting incentives
- Using change management models
- Understanding the cultural context of the organization

The event will be held in collaboration with the Cyprus Association of Educational Leadership.

The purpose of this hybrid lecture is to highlight the modified business models used in higher, secondary, and primary education. The focus is on a modified Total Quality Management (TQM) model that does not damage the scholarly values of higher education and which enhances professional autonomy, including academic freedom and academic quality in teaching and research. The issues caused by TQM as a form of new public management should be taken into consideration, including overload in teaching, administrative tasks, faculty turnover and the reasons behind this along with the quality of teaching and research. Inapplicable TQM concepts should be modified based on traditional university management models to fit the higher educational context, taking into account higher education leadership and the cross-cultural context that universities operate in.

Total Quality Management (TQM) practices are well established in higher education. However, their application in primary and secondary schools is less well established. The discussion will include different applications of TQM in primary and secondary schools. The majority of schools used certain principles of TQM but did not follow a holistic approach. The adoption of TQM in schools improved learning outcomes, empowered personnel, and promoted a culture of continuous improvement. The obstacles encountered were mainly related to mentality or culture. Several case studies will be examined and described providing insight into the effect of TQM practices on school environments. This will allow practitioners to gain in-depth knowledge about the impact of school TQM practices. The discussion will further propose key dimensions that require consideration for successful TQM implementation and offer useful information to school stakeholders, and potentially policymakers.
